## **Keynote Speaker**

Matthew Welickovitch, Assistant District Attorney, Lycoming County District Attorney's Office

Attorney Welickovitch began his legal career as a full-time bro pono attorney with North Penn Legal Services in 2015 before moving to the public defender's office. He spent six years in the public defender's office, eventually becoming First Assistant Public Defender. He transferred to the Lycoming County District Attorney's Office in 2021, where he is still employed. Attorney Welickovitch has extensive trial experience and has both represented and prosecuted the whole spectrum of crimes up to and including homicide. He has been a volunteer with Layers Concerned for Lawyers since 2015, having been awarded statewide volunteer of the year in 2019.

Attorney Welickovitch has an extensive background with treatment court programs, having actually graduated from Lycoming County's DUI Court program in 2012. He has been a member of the Lycoming County Treatment Courts Committee the entire eight years he has been with the county, both as a public defender and district attorney. He participated on the PA Treatment Court Accreditation Committee from 2017 to 2022; became a Certified Recovery Specialist in 2019; has facilitated a weekly SMART recovery meeting since 2020; and has been a certified Yoga instructor since 2021, teaching a weekly yoga class for people in recovery.

## Luncheon Speaker

## The Honorable Mark A. Kearney, United States District Court, Eastern District of Pennsylvania

On December 4, 2014, following a unanimous voice vote in the United States Senate, President Barack Obama commissioned Mark A. Kearney as the 100th judge in the history of the United States District Court for the Eastern District of Pennsylvania. He also presently sits by designation in the United States District Court for the District of Delaware.

The 2014-2015 President of the Pennsylvania Bar Institute and 2009 President of the 2200-member Montgomery Bar Association, his national law practice from 1988 to 2014 concentrated in commercial, financial, employment and consumer litigation with special emphasis on the representation of business owners, investors, directors and officers. His varied experience included serving as lead counsel for both plaintiffs and defendants in class actions, multi-district litigations, mass tort actions, and in regulatory investigations throughout the United States. Recognizing his winning strategies, the Montgomery Bar Association honored Judge Kearney as the 2014 Trial Lawyer of the Year. He was repeatedly elected (2011-2015) as a Top 100 lawyer in Pennsylvania and in the Philadelphia Metropolitan area by Thomson Reuters. Benchmark Litigation selected Judge Kearney as one of the top 50 "Litigation Stars" in Pennsylvania for 2013 and 2014. Judge Kearney received the highest peer rating of AV from Martindale Hubbell since he became eligible in 1992 until joining the District Court in 2014.

Judge Kearney received his Bachelor's in Arts in Economics and English with honors followed by his Juris Doctorate from Villanova University in 1987. He served as the judicial law clerk for the Honorable Maurice A. Hartnett, III of the Delaware Court of Chancery following law school. A member of the Delaware and Pennsylvania Bars, he is published as a lead author on Delaware fiduciary standards in two editions of the Villanova Law Review (1995, 1996) and was a multi-year contributing editor to Butterworths Journal of International Banking and Financial Law, where he wrote extensively on commercial, banking, and corporate litigation for the international legal and financial community. He presently serves on Villanova Law School's Board of Consultors. He presently serves as the Chair of the District Court's Community Outreach Committee, Chair of the Pennsylvania Bar Association Law Related Education Committee, and a Vice Chair of the Pennsylvania Bar Association's Federal Practice Committee. He is adjunct professor on trial advocacy and frequent speaker on leadership and mentorship to business and legal communities.
